27-10-1. Supervision and control of state highway patrol.

There shall be a state highway patrol under the supervision and control of the commissioner of public safety.

27-10-2. Commissioner's powers over patrol.

The commissioner of public safety shall:

(a) Divide the state highways into sections for the purpose of patrolling and policing the same and employ persons to patrol or police said highways, such persons shall be known as patrols.

(b) Establish ranks, grades and positions in the state highway patrol and designate the authority and responsibility in each rank, grade and

position.

- (c) Establish for the state highway patrol standards and qualifications and fix prerequisites of training, education and experience for each rank, grade and position, and shall fix salaries for each rank, grade and position in accordance with salary standards adopted by the Department of Finance.
- (d) Appoint such personnel to each rank, grade and position as are deemed by him to be necessary for the efficient operation and administration of the state highway patrol and devise and administer examinations, designed to test applicants for the positions, and any persons applying shall be required to meet the prescribed standards and prerequisites.
- (e) Formulate such rules and regulations governing the state highway patrol as from time to time appear to him advisable.
- (f) Discharge, demote or temporarily suspend any employee in the state highway patrol.
- (g) Prescribe the uniforms to be worn and the equipment to be used by employees of the state highway patrol.
- (h) Charge against each employee of the state highway patrol the value of any property of the state lost or destroyed through the carelessness of such employee.
- (i) Establish, with the approval of the state Department of Finance, the terms and conditions under which expense allowance should be paid to any employee of the state highway patrol while away from his station.
- (j) Station the state highway patrol in such localities as he shall deem advisable for the enforcement of the laws of this state.
- (k) Conduct in conjunction with the department of education in and through all state schools a definite educational campaign in highway safety and work in conjunction with civic organizations, churches, local units of government and other organizations which may function in accomplishing the purposes of reducing highway accidents.

NOTES TO DECISIONS

Determination of suspended officer's rank upon reinstatement.

It was proper, under the terms of this section, for the Highway Patrol Civil Service Commission to order, upon suspension of an officer, that he should be reinstated if he could show his rehabilitation from alcoholism and

that his rank upon reinstatement should be determined by the commissioner of public safety; it was not necessary that the commission itself make the determination of rank. Helm v. Utah State Hwy. Patrol Civil Serv. Comm'n, 556 P.2d 210 (Utah 1976).

The state through the state purchasing agent of the Department of Finance shall purchase or otherwise obtain and furnish to the state highway patrol upon the requisition of the commissioner of public safety uniforms and supplies necessary for the efficient performance of the duties of the state highway patrol.

27-10-4. Duties of Utah Highway Patrol.

- (1) The Utah Highway Patrol shall:
 - (a) enforce the state laws and rules governing use of the state high-ways;
 - (b) regulate traffic on all highways and roads of the state;
 - (c) respond to the call of the governor for emergency or other purposes at his discretion, and to the call of the Alcoholic Beverage Control Commission in an emergency to enforce the state liquor laws;
 - (d) provide security and protection for both houses of the Legislature while in session as the speaker of the House of Representatives and the president of the Senate finds necessary.
- (2) The Department of Public Safety shall carry out the following for the Supreme Court and the Court of Appeals:
 - (a) provide security and protection to those courts when in session in the capital city of the state;
 - (b) execute orders issued by the courts; and
 - (c) carry out duties as directed by the courts.

27-10-5. Vested with powers of peace officers.

The commissioner of public safety and each member of the state highway patrol is vested with the powers of peace officers throughout the several counties of the state with the exception of the power to serve civil process. They may serve criminal process and arrest and prosecute violators of any law of this state and shall have the same right as other peace officers to require aid in executing their duties. The powers and duties hereby conferred upon the commissioner of public safety and members of the highway patrol shall be supplementary to and in no way a limitation on the powers and duties of other peace officers in the state.

27-10-6. Cooperation with other officers.

The state highway patrol shall cooperate and exchange information with any other departments of the state or with other police forces, both within and outside this state, and with federal police forces, to secure information in order to achieve greater success in prevention and detection of crime and apprehension of criminals.

27-10-7. Operation and maintenance of inspection and checking at ports of entry — Port personnel.

- (1) The inspection and checking ports of entry constructed, in process of construction, or to be constructed by the Transportation Commission shall be operated and maintained by the state highway patrol. Personnel employed to operate the ports of entry and the maintenance of physical plants are the responsibility of the state highway patrol.
- (2) In the operation of inspection and checking ports of entry, the highway patrol shall employ special function officers under Section 77-1a-4 or civilian clerks, as determined necessary by the commissioner of public safety.

27-10-8. Field strength of highway patrol.

The Department of Public Safety is hereby directed to provide on or after July 1 of each calendar year one highway patrolman in the field, including field supervisors, for each 3,800 vehicles registered in the state as shown on the records of the state tax commission as of December 31 of each preceding calendar year. The vehicle registration is to be computed by deducting all transfers of registration from the gross registration.
